1. Introduction

STEP 1

Register required information in the GMS

All participants must register all required information in the GMS.

Regardless of whether or not you need to apply for a visa, all participants must register in the GMS. Only participants in status "approved" will be provided with the visa assistance.

STEP 2 Check the Countries or Regions that require a visa to enter Japan

Please be sure to register on Visit Japan Web before your departure. (This procedure is required for all visitors to Japan, regardless of whether or not a visa is needed.)

2. About Japanese Visa System

As a general rule, a "short-term single entry visa" is required to enter Japan for a stay of up to 90 days for tourism, business, visiting friends or relatives, etc.

2.1 Exemption of Visa

The Japanese visa exemption arrangements are available for passport holders of the 68 countries/ regions as shown in the chart below (as of December 2022).

However, some countries are 'conditionally exempt' from visa requirements, depending on the notes. In such cases, you will need to check the requirements for exemption and, if not exempt, please make sure to apply for a visa.

If you do not apply, a visa will not be issued and you will not be allowed to enter Japan.

- Period of Stay The period of stay granted at the time of the landing permission will be "15 days" for Indonesia and Thailand, "14 days" for Brunei, "30 days" for United Arab Emirates and "90 days" for other countries and regions.
- (Note 1) For nationals of Indonesia (since 1 December, 2014), visas are not required only for those who have registered ICAO-compliant ePassport to diplomatic missions of Japan in Indonesia (the embassy, consulates-general, or the consulate). Validity of the registration is three years period or until the passport expires, whichever comes first.
- (Note 2) For nationals of United Arab Emirates (since 1 November, 2022), Thailand (since 1 July, 2013) and Serbia (since 1 May, 2011), visas are not required only for holders of ePassport in compliance with ICAO standards. Those who do not hold such ePassport are requested to obtain a visa in advance, otherwise will be refused to enter Japan.
- (Note 3) For nationals of Malaysia (since 1 July, 2013), visas are not required only for holders of ePassport in compliance with ICAO standards. Those who do not hold such ePassport are advised to obtain a visa in advance, otherwise will be strictly examined and may be refused entry to Japan.
- (Note 4) Visa exemption arrangements for Taiwan is limited to passport holders with a personal ID number.
- (Note 5) For citizens of Hong Kong, visas are not required only for holders of Special Administrative Region (SAR) passport issued by the Hong Kong SAR of the People's Republic of China or British National Overseas (BNO) passports who have the right of residence in Hong Kong.
- (Note 6) For citizens of Macao, visas are not required only for holders of SAR passport issued

by the Macao SAR of the People's Republic of China.

- (Note 7) For nationals of Barbados (since 1 April, 2010), Turkey (since 1 April, 2011) and Lesotho (since 1 April, 2010), visas are not required only for holders of Machine-Readable Passport (MRP) in compliance with ICAO standards. Those who do not hold an MRP are advised to obtain a visa in advance, otherwise will be strictly examined and may be refused entry to Japan.
- (Note 8) For nationals of those countries with visa exemptions permitting stays of up to 6 months under the bilateral visa exemption arrangements, those who wish to stay in Japan for more than 90 days are required to apply for an extension of the period of stay to the Ministry of Justice (Regional Immigration Bureau) before the period of permitted stay is to expire.

2.2 Passport

All participants must carry a government-issued passport or a travel document equivalent to a passport to enter Japan. Please carry it with you during your stay in Japan, not only at the time of entering the country.

A passport valid for at least six months after entry into the country is required.

2.3 Japanese diplomatic missions abroad

It is a requirement on the GMS to fill out information regarding the country and city of the diplomatic mission in which you will be applying for and receiving your visa. No changes can be made after the submission of registration because Fukuoka OC will consult with the central government based on the information provided.

Some Japanese diplomatic missions abroad have jurisdiction over several countries/ regions (please note that Japanese diplomatic missions abroad are not located in all countries/ regions). If it is not located in your country, you will have to apply to a diplomatic mission in a neighbouring country that has jurisdiction over your country. It is therefore recommended to allow plenty of time for visa applications.

Each diplomatic mission has its own website, which you are advised to check before making an enquiry.

3. Visa Application Procedures

3.1 Procedures Chart

Please complete the registrations of your participants in the GMS. Each nomination must be duly submitted with all requested information for the OC to prepare the invitation letter.

Attention! It is a requirement on the GMS to fill out information regarding the country and city of the diplomatic mission in which you will be applying for and receiving your visa. No changes can be made after the submission of registration because Fukuoka OC will consult with the central government based on the information provided.

Despite registering in the GMS that the participant need a visa, if the name of the participant is not on the 'List of eligible person for visa issuance', it means that the participant has been refused a visa for some reason. In this case, the participant will not be allowed to enter the country.

The Ministry of Foreign Affairs does not disclose the reason for the rejection of the application.

3.2 Purpose of visit

The documents required for visa application depend on the purpose of the visit to Japan, but for Championships' officials and athletes, the purpose is 'short-term business purposes'.

3.3 What is required for the application

[To be prepared by Applicants]

Some countries/ regions require additional documents other than below. You must check the website above for more details.

• Passport (with the validity of at least 6 months after entry into the country)

Some countries have special regulations regarding the validity of passports, so please check with the diplomatic mission where you are applying for your visa in advance.)

• Visa application form (there is a form prescribed by the diplomatic mission abroad where the application is made.)

- · Photo (Please check the size of photo on the website as it varies by country)
- · Visa issuance fee (Approx. 3,000 yen, borne by applicants)
- · Other documents required by the Japanese diplomatic mission abroad

- Invitation Letter
- *In order for Fukuoka OC to issue the document, the applicant must correctly register the information in the GMS. Please make sure to register accurate information.
- * Please carry the documents sent by Fukuoka OC together with your passport so that you can present them during immigration procedures, just in case.

3.4 Points to note on application

(1) It is strongly recommended that the GMS registration (which must be approved by World Aquatics after registration) be completed <u>8 weeks before</u> the intended date of travel in order to apply for a visa. It takes longer for a visa to be issued if the application documents are incomplete.

*It takes some time to receive the 'Invitation Letter', which is necessary for visa applications, as it is issued by the OC after the person has been registered and approved in the GMS and a decision has been made by the Ministry of Foreign Affairs to issue a visa (We will issue the list within a few days upon receiving it from the Ministry of Foreign Affairs). It takes

- about 2 3 weeks from GMS approval to issuance of the letter.
- (2) If you have circumstances that may require your date of entry to Japan to be earlier, please be particularly careful. In case of last minute, World Aquatics/OC procedures may not be completed in time.
- (3) Please apply at the Japanese Embassy/ Consulate General located in your country (region) of origin or country (region) of residence (or the nearest diplomatic mission with jurisdiction over your place of residence if there is more than one). As a general rule, an application cannot be made at the country of travel, but if there are unavoidable circumstances and you wish to apply at the country of travel, please consult in advance.
- (4) According to Japanese law, visa issuance fees must be paid in cash in local currency. Payment by credit card or electronic money is not accepted.
- (5) Based on the data registered in the GMS, Fukuoka OC will coordinate visa issuance with the Japanese government, so please do not apply on your own initiative or contact the diplomatic mission abroad regarding the timing of visa issuance until the OC sends you the necessary documents for visa application.

*Please note that the visa is valid for 3 months from the day after it is issued. You must undergo immigration clearance in Japan within the period of validity. The visa validity period cannot be extended, and you will not be allowed to enter Japan after the expiry date of the visa. Please consider your planned date of entry into Japan carefully before applying for a visa.

3.5 Application to Japanese diplomatic missions abroad

To apply for a visa, prepare the relevant documents and apply in one of three ways: (1) in person at the Japanese embassy or consulate-general; (2) by a representative holding a letter of attorney at the Japanese embassy or consulate-general; or (3) at a proxy application organisation approved by the Japanese embassy or consulate-general. However, depending on the circumstances in each country, there may be cases where the applicant must be present in person as a general rule, or where the application must be made via a proxy application organisation as a general rule. Consequently, please check in advance with the embassy or consulate-general where the application is to be made.

Once the examination is over and the visa has been issued, you will need to go back to where you submit the application to pick up your visa.

4. Entry Restrictions in Japan to prevent the spread of COVID-19 (as of Dec 2022)

[Note]

To enter Japan, either a "Vaccination Certificate recognized by the Japanese Government (4.1)" or a "Test Result Certificate before departure (4.2)" for each entrant is required.

Failure to present either of these valid proofs at the point of entry will result in refusal of landing in Japan.

Please be sure to register on Visit Japan Web before your departure. (<u>This procedure</u> is required for all visitors to Japan, regardless of whether or not they need a visa.)

4.1 Vaccination Certificate recognized by the Japanese Government

For certificates issued outside of Japan will need to satisfy all of (1) to (3), regardless of the country or region of issue.

(1) The following items must be indicated in Japanese or English

Name, date of birth, vaccine name/manufacturer, date of vaccination, number of doses administered. (Note 1)

- (Note 1) If the vaccination certificate is in a language other than Japanese or English, it may be considered valid if it is accompanied by a Japanese or English translation and the content can be confirmed.
- (2) The certificate must clearly show that you have received (3) doses of any of the following vaccines on the Emergency Use Listing of World Health Organization

- ODoses will also be considered valid even if each dose are not the same vaccine.
- For the JCOVDEN intramuscular injection/Janssen and CONVIDECIA/CanSino Biologics only in case of primary series, one dose is considered equivalent to two doses.

(3) The certificate must be issued by a government or public institution

4.2 Test Result Certificate before departure

All entrants (including Japanese citizens) who do not have a valid vaccination certificate must be tested within 72 hours of departure and a negative test result certificate issued by a medial institution must be presented to the quarantine station at the time of entry.

Those who are unable to present a valid vaccination certificate or a valid test result certificate will not be allowed to enter Japan, as based on Quarantine Law.

In addition, please note that in the country of departure, if you do not have neither a valid vaccination certificate nor a valid test result certificate before boarding, you will be denied boarding the aircraft.

In cases where it is difficult or truly unavoidable to obtain an inspection certificate, please consult with the diplomatic mission abroad.

A test result certificate is valid as long as all of the following items are satisfied, and all the items are written in English or Japanese.

Required Items

- (1) Name
- (2) Date of birth
- (3) Testing method for COVID-19 (refer to the valid testing method)
- (4) Sample (refer to the valid sample)
- (5) Specimen collection date and time (refer to the timing of specimen collection)
- (6) Test Result
- (7) Name of medical institution
- (8) Date of issue

Valid Test Method

The following is a list of valid test methods for entry into Japan.

- ONucleic Acid Amplification Test
 - PCR (Polymerase Chain Reaction)
 - · LAMP (Loop-mediated Isothermal Amplification)
 - TMA (Transcription Mediated Amplification)
 - TRC (Transcription Reverse-transcription Concerted reaction)
 - Smart Amp (Smart Amplification process)
 - NEAR (Nicking Enzyme Amplification Reaction)
 - Next Generation Sequence
- ○Quantitative Antigen Test (CLEIA、ECLIA)※
 - XNot a qualitative antigen test.
 - Note) the certificate will be not be valid if contains an invalid (not recognized in Japan) specimen name or test method, such as "Throat (swab/smear)" as a specimen, and "Rapid antigen (test/kit)" as a test method. Please be sure to check thoroughly with the local medical authorities when acquiring the certificate.

Valid Sample

Sample collection method is valid only for one of the following.

- Nasopharyngeal Swab
- · Nasal Swab X
- Saliva
- Nasopharyngeal and Oropharyngeal Swabs

*Nasal Swab is valid when the test method is Nucleic Acid Amplification test.

•Timing of Specimen Collection

The period between the date of specimen collection and the scheduled departure time of the flight must be within 72 hours.

4.3 Others

Those entering Japan with symptoms of suspected COVID-19 infection will be tested upon arrival. Furthermore, those who test positive will be required a quarantine at the designated facility in accordance with the instructions of the quarantine station chief.

The cost of medical treatment in the event of a positive test result during the stay in Japan and the cost of a test if negative proof is required on return home are to be borne by the participant.
