FR 2 - SWIMMING POOLS

POOL No

MEASUREMENT CRITERIA

- 1.- The measurements shall be done by a certified surveyor, appointed or approved by the Member in the country in which the pool is situated.
- 2.- The surveying equipment shall be a Total Station. The minimum requirements of the Total Station are the following:
 - Angle Measurement Accuracy Hz and V: 1" (0.3 mgon)
 - Distance Measurement Accuracy: 1mm + 1.5ppm
- 3.- The surveyor shall provide a Calibration Certificate confirming the measurement quality of surveying equipment. The certificate will have a maximum validity of 1 year.
- 4.- All dimensions shall be measured using a mini prism or targets.
- 5.- The measurements corresponding to the FR 2.1, 2.2, 2.5, 2.6 and 2.7 shall be measured with the pool full of water. The water level can be lowered up to 5cm to avoid water reflection when measuring.
- 6.- The measurements corresponding to the FR 2.3, 2.4, 2.14 should be measured with the empty pool.
- 6.- The water temperature shall be 25° to 28 °C.
- 7.- The length of the pool FR 2.1, 2.2 shall be measured in the centre of each lane.
- 8.- The width of the pool shall be measured in both ends of the pool.
- 9.- The depth of the pool FR 2.3 shall be measured at least in 5 points per lane: 1 m and 6 m from each end wall and in the centre of the pool.
- 10.- The verticality of the end walls FR 2.4 shall be measured in the centre of each lane. The end walls shall be vertical and form 90 degrees right angles. The admissible tolerance in walls verticality will be ±0.30°.

ORTHOGONALITY OF THE POOL

The sides of the pool shall be orthogonal and form 90 degrees right angle. The tolerance of the angle is $\pm 0.05^{\circ}$. The 2 diagonals shall be the same length. The tolerance of the diagonal is 10mm.







Width: There is no restrictions in width.


FR 2.5: Lanes shall be at least 2.5 metres wide, with two spaces of at least 0.2 metre outside of the first and last lanes.

FR 2.3 - DEPTH

FR 2.3 - A minimum depth of 1.35 metres, extending from 1.0 metre to at least 6.0 metres from the end wall is required for pools with starting block. A minimum depth of 1.0 metre is required elsewhere.

FR 2.4 - WALLS

FR 2.4.1 - End walls shall be vertical, parallel and form 90° right angles to the swimming course and to the surface of the water. They shall be constructed of solid material, with a non slip surface extending 0.8 m below the water surface. The tolerance in walls verticality will be ±0.3°.

FR 2.4.2 - Rest ledges along the pool walls are permitted; they must be not less than 1.2 metres below the water surface, and may be 0.1 metre to 0.15 metre wide. Both internal and external ledges are acceptable, however internal ledges are preferred.




FR 2.7 - STARTING PLATFORMS


FR 2.7 - Starting Platforms shall be firm and give no springing effect. The height of the platform above the water surface shall be from 0.5 metre to 0.75 metre. The surface area shall be at least 0.5 metre x 0.5 metre and covered with a non-slip material.


Maximum slope shall not be more than 10 degrees. The starting platform may have an adjustable setting back plate. The platform shall be constructed so as to permit the gripping of the platform by the swimmer in the forward start at the front and the sides; it is recommended that, if the thickness of the starting platform exceeds 0.04 metre, grips of at least 0.1 metre width on each side and 0.4 metre width in the front be cut out to 0.03 metre from the surface of the platform. Handgrips for the forward start may be installed on the sides of the starting platforms. Handgrips for backstroke starts shall be placed within 0.3 mete to 0.6 metre above the water surface both horizontally and vertically. They shall be parallel to the surface of the end wall and must not protrude beyond the end wall.

A minimum depth of 1.35 metres, extending from 1.0 metre to at least 6.0 metres from the end wall is required for pools with starting blocks. Electronic read-out boards may be installed under the blocks. Flashing is not allowed. Figures must not move during a backstroke start.

Distinctive marks must be placed on both sides of the pool, and where possible on each lane rope, 15.0 metres from each end wall. | | | |

FR 2.10 - BACKSTROKE LEDGE

FR 2.10 - A backstroke ledge may be used:

- The ledge may be adjustable to 4 cm above or 4 cm below the water level.
- The ledge is a minimum of 65 cm in length.
- The ledge must be 8 cm in height, 2 cm at the width with 10 degrees of slope

| FR 2.12.2 - Water Movement. During competition the water in the pool must be at a constant level, with no appreciable movement. In order to keep the water level, preserve the transparency of water and take into consideration the health regulations in force in most countries, inflow and outflow has to be regulated as follows: - 220 to 250 m3/h for 50.00 m pools - 150 to 180 m3/h for 33.33 m pools - 120 to 150 m3/h for 25.00 m pools In daily use, inflow and outflow has to follow the health regulation of each country At these turnover rates, the water distribution has to be such that no appreciable current or turbulence is created. Appreciable current or turbulence test should be done as detailed in the FR2.12.2 The video/s and an annexe with at least 6 frames (1 frame / 10 seconds) per test shall be issued | | | |

FR 2.14 - LANE MARKINGS

FR 2.14 Lane Markings - shall be of a dark contrasting colour, placed on the floor of the pool in the centre of each lane. Width: minimum 0.2 metre, maximum 0.3 metre.

Length: 46.0 metres for 50 metre long pools / 21.0 metres for 25 metre long pools.

Each lane line shall end 2.0^{\star} metres from the end wall of the pool with a distinctive


cross line 1.0 metre long and of the same width as the lane line. Target lines shall be placed on the end walls or on the touch panels, in the centre of each lane, of the same width as the lane lines. *Pool length tolerances must be considered.

They shall extend without interruption from the deck edge (curb), to the floor of the pool to a maximum of 3 metres. A cross line 0.5 metre long shall be placed 0.3 metre below the water surface, measured to the centre point of the cross line.

For 50m and 25m pools constructed after 1 January 2006, cross lines 0.5 metre long shall be placed at the 15 metre mark from each end of the pool. After October 2013 this shall be measured from the end wall to the centre point of the cross line.

FR 2.15 - BULKHEADS

COMMENTS

FR 2.15 Bulkheads – When a bulkhead serves as an end wall, it must extend the full width of the course and present a solid smooth, non-slippery stable vertical surface on which touch pads may be mounted extending not less than 0.8m below and 0.3m above the surface of the water, and must be free of hazardous openings above or below the waterline which may be penetrated by a swimmer's hands, feet, toes or fingers. A bulkhead must be of a design that provides for the free movement of officials along its length without such movement creating any appreciable current or water turbulence.
