






II. PREVENTION ACTIVITIES



- Twelve (12) monthly Anti-Doping education webinars for athletes and support personnel, organised in cooperation with the International Testing Agency (ITA).
- Two reminders were sent to Member Federations and Registered Testing Pool Athletes about the 2025 World Anti-Doping Agency (WADA) Prohibited List, which took effect on 1 January 2025.
- The AQIU met with European Member Federations during the European Aquatics Championships 2024 in Belgrade, Serbia to discuss how the AQIU can help them prevent Integrity issues in their respective countries. The AQIU also met with the Integrity Unit of European Aquatics at the same event to discuss collaboration and share best practices.
- The AQIU presented during a webinar organised by PANAM Aquatics for athletes. The presentation focused on the best practices to avoid non-intentional Anti-Doping rule violations.
- The AQIU presented during a webinar on good governance organised by World Aquatics for Member Federations. The presentation focused on the importance of having an Integrity Code and an independent structure in place.
- The AQIU organized an education session on Manipulation of Competitions for International Technical



Officials appointed for Paris 2024 in cooperation with the Olympic Movement Unit on the Prevention of the Manipulation of Competitions.


- The AQIU organized an Anti-Doping workshop for athletes during the World Aquatics Championships in Doha with the collaboration of the WADA President and other worldrenowned anti-doping experts.
- The AQIU set up an Anti-Doping education booth in the Athletes' lounge and in market street during the World Aquatics Championships in Doha.
- All athletes taking part in the World Aquatics Championships in Doha and the World Aquatics Swimming Championships in Budapest had to complete an eLearning course on anti-doping prior to their participation.
- The AQIU organized educational sessions with technical committees during the World Aquatics Championships in Doha.

III. CAPACITY BUILDING ACTIVITIES



- Assistance of PanAm Aquatics with the finalisation of their Integrity Code.
- A safeguarding plan was put in place for the World Aquatics Training Centres. All centres now have a dedicated safeguarding officer.
- The AQIU held meetings with all Continental Organisations and Member Federations during the World Aquatics Championships in Doha to assist them in implementing their Integrity Code.
- The AQIU organized a Sports Integrity Seminar during the World Aquatics Swimming Championships (25m). The seminar was attended by more than 100 experts in the field of sport integrity.







IV. OTHERS

 Review of one hundred and eight (108) applications for status of Neutral Athlete and Neutral Athlete Support Personnel. Fifty-three (53) applications were approved, six (6) were rejected as they did not meet the Anti-Doping requirements and forty-nine (49) remained under review at the end of the year. These forty-nine (49) applications were subsequently approved in 2025.



- The Chair of the AQIU Supervisory Council, Mr. Miguel Cardenal and the Vice-Chair, Mr. Ken Lalo were appointed to the independent audit review committee created by World Aquatics to enhance their understanding of the anti-doping review and decision-making process within World Aquatics.
- The AQIU Supervisory Council met 12 times in 2024 to discuss ongoing matters and ensure smooth running of the operations of the AQIU.
