DRAWING SUBMITTAL REQUIREMENTS

As part of the pool certification document, the organizing body is required to submit drawings of the pool and associated competition areas for review in addendum with this document. These drawings must be in scale and reflect the as-built condition of the facility. The drawings must include:

- A BUILDING PLAN VIEW, INCLUDING THE FULL DECK WIDTHS AND SPECTATOR SEATING AREAS;
- 2. A POOL PLAN VIEW WITH CORRESPONDING WATER DEPTHS;
- 3. A POOL LONGITUDINAL SECTION VIEW WITH CORRESPONDING WATER DEPTHS:
- 4. AND A POOL CROSS SECTION VIEW WITH CORRESPONDING WATER DEPTHS.

MEASUREMENT CRITERIA

- 1. THE MEASUREMENTS SHALL BE DONE BY A CERTIFIED SURVEYOR, APPOINTED OR APPROVED BY THE MEMBER IN THE COUNTRY IN WHICH THE VENUE IS LOCATED.
- 2. THE SURVEYING EQUIPMENT SHALL BE A TOTAL STATION. THE MINIMUM REQUIREMENTS OF THE TOTAL STATION ARE THE FOLLOWING:
 - 2.1 ANGLE MEASUREMENT ACCURACY HORIZONTAL AND VERTICAL: 1" (0.3 MGON)
 - 2.2 DISTANCE MEASUREMENT ACCURACY: 1MM + 1.5PPM
- 3. THE SURVEYOR SHALL PROVIDE A CALIBRATION CERTIFICATE CONFIRMING THE MEASUREMENT QUALITY OF SURVEYING EQUIPMENT. THE CERTIFICATE SHALL HAVE A MAXIMUM VALIDITY OF 1 YEAR.
- 4. ALL DIMENSIONS SHALL BE MEASURED USING A MINI PRISM OR TARGETS.THE DEPTH OF THE POOL SHALL BE MEASURED WITH THE POOL EMPTY.
- 5. ALL THE OTHER MEASUREMENTS SHALL BE MEASURED WITH THE POOL FULL OF WATER.
- 6. THE WATER TEMPERATURE SHALL NOT BE LESS THAN 26° ± 1° CENTIGRADE PER PART 6, 18.2.4.



TYPE OF VENUE

The facility shall identify the construction material (i.e. Concrete, Stainless Steel, etc.) and pool finish type (i.e. Paint, Plaster, Tile, Liner, etc.).

WATER POLO POOL - GENERAL DIMENSIONS

The sides of the pool shall be orthogonal and form 90 degrees right angle. The tolerance of the angle is $\pm 0.05^{\circ}$. The 2 diagonals shall be the same length. The tolerance of the diagonal is 10mm.





PART 6, 18.2.2 - The overall Field of Play will be $30.60m \times 20.00m$ for men and $25.60m \times 20.00m$ for women. The distance between respective goal lines shall be 30.00m for games played by men and 25.00m for games played by women. The anchor point at the edge of the Field of Play shall be placed 30cm behind the front of the goal line. The width of the Field of Play shall be 20.00m. The depth of the water shall be consistently not less than 2.00m.
